A tax rate of \$0.49602 per \$100 valuation has been proposed by the governing body of LIVE OAK COUNTY.

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for LIVE OAK COUNTY from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that LIVE OAK COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that LIVE OAK COUNTY is proposing to increase property taxes for the 2022 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 12, 2022 AT 9:00 AM AT Live Oak Co. Commissioners Court 301 Houston St., George West, Texas 78022.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, LIVE OAK COUNTY is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Live Oak County Appraisal District of LIVE OAK COUNTY at their offices or by attending the public hearing mentioned above.
