### **\$35.00 fee for each returned check**

\$26.00 for 1st page, \$4.00 for each additional. Any information on the back of a page is considered an additional page. \$0.25 per name after the first 5 names to be indexed. **Please include a self-addressed, stamped envelope.**

\* Texas Property Code 11/003 effective 1.1.1982 requires that each grantee's mailing address be in or attached to any document conveying real property executed after 12.31.1981. If address of each grantee is not included, the payment of a penalty filing fee equal to the greater of (1) twice the statutory filing fee for the filings of such document with the County Clerk or (2) \$25.00 will be required. This fee is in addition to regular filing fees. LGC 191.007(h): Provides double the filing fee for that page if names are not legibly typed or printed immediately under each signature. LGC 191.007(3): Printed in type no smaller than 9 point type. Property Code 12.001(b) & 12.011: Must have original signature and proper acknowledgments. No e-filing for Real Property Recordings.

Effective July 1, 2001, County Clerks will no longer accept UCC Filings except in the Real Estate Records. All other UCC filings must be filed with the Office of Secretary of State in Austin. Contact UCC Division 512.475.2700.

## Marriage License

72 hr waiting period from date of application before license may be used. The license expires if a marriage ceremony is not conducted before the 91st day after the date of issuance. A new one must be purchased. (Texas FC, Sec. 1, (a) Sec 1.81). Both parties must be present and have photo ID and Social Security card.
